The following amendments to Article III of the By-Laws and to Article X of the Articles of Incorporation are proposed by the Board of Directors and will be voted upon at the May 21 meeting:

MEMBERSHIP

Section 1. MEMBERS AND HONORARY MEMBERS

Membership in the Foundation shall be made up of all persons and groups set forth in Section 2 hereof, plus such honorary members or advisory Board Members as shall be named by the Board of Directors from time to time.

(con't.)

Section 2. MEMBERSHIPS

a) Individual Members shall be those individuals who shall make an annual contribution of TEN (\$10.00) DOLLARS to the Foundation for any of its purposes, programs, expenses or other lawful or legitimate expenses or expenditures. The Executive Committee shall cause to be issued receipts to each such member upon receipt of their contribution, and to all other members.

b) Family Members shall be those two or more members of a single family who shall make an annual contribution of FIFTEEN (\$15.00) DOLLARS to the Foundation and who shall have a maximum of TWO (2) VOTES.

c) Contributing Members shall be those persons, associations, partnerships and corporations who shall make an annual contribution of TWENTY-FIVE (\$25.00) DOLLARS to the Foundation and who shall have a maximum of TWO (2) VOTES.

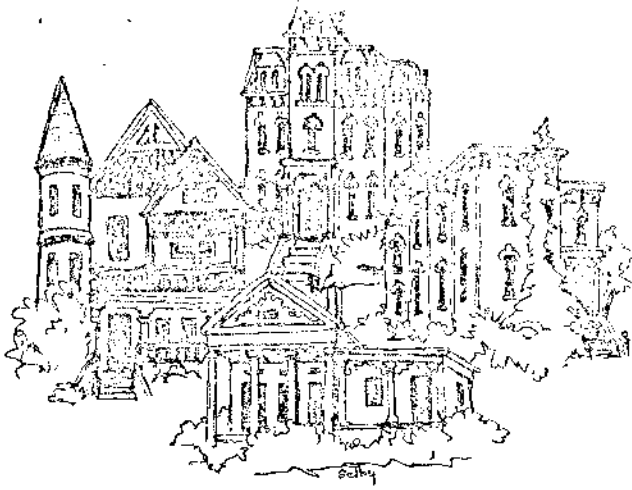
d) Sustaining Members shall be those persons, associations, partnerships and corporations who shall make an annual contribution of ONE HUNDRED (\$100.00) DOLLARS to the Foundation and who shall have a maximum of TWO (2) VOTES.

e) Life Members shall be those persons, associations, partnerships and corporations who shall make a contribution of ONE THOUSAND (\$1,000.00) DOLLARS to the Foundation and who shall have a maximum of TWO (2) VOTES.

f) All members shall be voting members, including such honorary members as may be named by the Board of Directors.

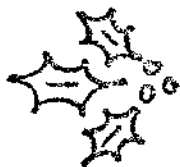

TOWNER HOUSE

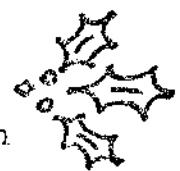

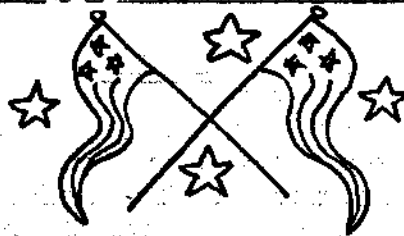
PARADE

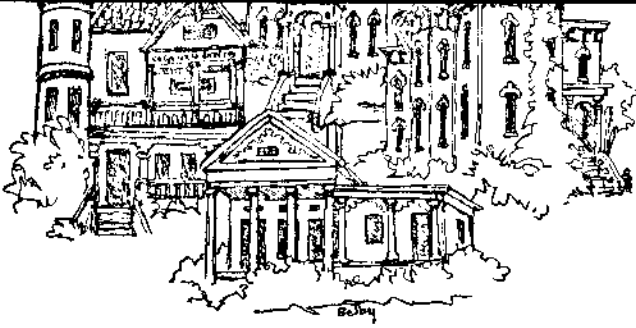
This event, planned for the 3rd of July, was cancelled when it was learned that the Historical Museum had similar plans still underway. This event has now been replaced by the Open House

SPEAKERS: Professor Richard Bilaitis, Department of Art and Curator of the WSU Collection, Wayne State University

Professor Bilaitis is a member of WSU President's new Historic Preservation Advisory Commission which consists of members from all areas of concern in matters of old buildings as they relate to the University and the community. Professor Bilaitis has been praised by Detroit architects for his work in the restoration of two important examples of domestic architecture in the WSU area. He was the inspiration behind student involvement and the preservation courses presently being taught at WSU. He will not only show us slides of the restoration work in progress there, but he has been quietly, shall I say almost secretively, taking pictures of towers in Ypsilanti - buildings which he hopes to compare/contrast with the Stacklewitz building. Above all, he will bring his experience to the discussion of alternatives in the question of what to do with a threatened structure.

Janet Kreger, M.A. (Columbia, in Historic Preservation!),

has actually taken her degree in that new area of higher education - historic preservation - and will bring her own point of view and her own experience (in New York and Michigan) to the discussion of alternatives.

We hope to have students, staff members and administrators from Eastern Michigan present and participating in the discussion. But above all we want not only members of the Heritage Foundation but as large a representation from the general public as we can muster. Call your friends and bring at least one!

Carl B. Westmoreland is well known nationally as a prime mover in the restoration and revitalization of two decaying neighborhoods in Cincinnati. With a graduate degree in urban sociology from the University of Cincinnati, he is by vocation a social planner, but he has given a great deal of his time, without pay, to the bootstrap efforts in Cincinnati to make specific areas of that city livable again. The once beautiful neighborhoods of Mt. Auburn and Madisonville, both deteriorated in varying degrees, have experienced a renaissance in recent years, with a good share of the credit going to Mr. Westmoreland. The organizations which he has supported and sometimes led have been exceptionally resourceful in obtaining funding. He has been equally adept at moving citizens, both property owners and tenants, to a new sense of pride in where they live. Being black himself, he is particularly interested in the problems which confront black people in decaying neighborhoods; but he speaks with a message that is meaningful to all of us, e.g.:

"I honestly believe that it is up to us who live in inner-city neighborhoods to change them, and we can only change them if we educate each other ... I see beauty where I live, and I'm responsible for the filth in the streets. My neighbors are responsible for it. We cannot depend on the benevolence of people who live outside our community. We have our own methods of doing things when we want to. An indifferent government makes it harder. An indifferent banker makes it harder. But it is not impossible."

**** U.S. SUPREME COURT UPHOLDS LANDMARKS LAW IN GRAND ****
**** CENTRAL CASE ****

In a stunning victory for historic preservation efforts across the country, the U.S. Supreme Court ruled on June 26 that New York City's landmark designation statute is constitutional. The decision upholds a city's right to make landmark designations to protect specific properties and to halt their demolition or alteration.

Although the case on which the court ruled concerned only New York's 1913 Grand Central Terminal, the decision strongly supports the validity of laws that created more than 500 landmark and historic district commissions in the United States. The court rejected a chief argument used to attack such commissions: That landmark designations deprive the owner of his constitutionally protected right to do anything he wishes with his property. That kind of argument, declared Justice William J. Brennan in the majority opinion, is "quite simply untenable".

"Approval by the Supreme Court is the ultimate test," said James Biddle, president of the National Trust for Historic Preservation, following announcement of the decision.

"Justice Brennan's careful analysis will encourage the cities having landmark or historic district laws to use them more vigorously. It should also encourage the passage of such laws in communities where the question of constitutionality has been debated," he added.

FALL ELECTIONS:

At its November meeting the Heritage Foundation held elections for positions on the Executive Board. We are also pleased to announce that the Executive Board re-elected Jane Bird, Nathalie Edmunds, and Mary Warner to new terms as President, Vice-President and Secretary-Treasurer, respectively. In addition, Nathalie Edmunds, will continue to serve as Program Chairwoman, and Jack Harris has agreed to continue editing the Newsletter. Rosalie Clavez will serve as publicity chairwoman for the Foundation.

MARKERS

The Foundation's Marker Committee is currently reviewing nominations for Historic Markers. The presentation of the 1979 awards will be held at the May meeting. The May Newsletter will contain information about the recipients of the awards.

YPSILANTI REHABILITATION ACTIVITIES AND IDEAS

DOWNTOWN REVITALIZATION:

As spring approaches there are many signs of revitalization visible in downtown Ypsilanti. Along North Huron Street, work continues on the interiors of the Old City Hall and the Beyer Apartment Building. The plans of the law firm, Stripp, Roberts, Manchester and Allen, to rehabilitate the Old Courthouse at 206 N. Huron Street have been approved by the Historic District Commission. Work has already begun on the interior there.

In Depot Town, the owners of Depot Exchange are planning to open their new bar, the Sidetrack, in a few days. The Sidetrack, which will serve sandwiches and feature jazz musicians, is located at 56 E. Cross Street, the site of the former Central Bar. The new owners have attempted to restore the building's significant details, its nineteenth century store front, the pressed tin ceiling, and the magnificent columned bar that takes up one whole wall. Inside they have removed the heating ducts from the ceiling and hidden them behind the walls, restored the original mahogany colored stain of the bar, and added turn of the century light fixtures. It promises to provide a very attractive interior.

CURRENT RESIDENTIAL REHABILITATION ACTIVITIES OF THE CITY

- 1) The Community Development Block Grant Program has 29 active applications, with construction taking place on five units. The City has obligated approximately \$30,000 and has a large amount of uncommitted money; income limits will be adjusted as permitted by the Department of Housing and Urban Development.
- 2) The Neighborhood Improvement Loan Program has recently been funded by the Michigan State Housing Development Authority. Beginning this month (March, 1979) low-interest loans (1% to 7% simple interest) will be available to persons owning/purchasing property in designated target areas. Income ceilings are \$14,000 after a \$750 deduction for every household member. Maximum loan principle is \$15,000 for single family dwelling units and \$5,000 per unit for structures at 2 to 4 units. The total amount of funding available is \$300,000 which must be expended within one year.
- 3) HUD Section 312 Loan Program. The City has been allocated \$100,000 in S.312 funding for 3% home improvement loans. Under this program, low income persons will be given priority. The City will advertise in the Ypsilanti Press when they are ready to begin this program.

Application's are welcome from all low to moderate income residents and property owners who plan to rehabilitate old houses. YOU may qualify for a low interest loan or grant. Tell others in your neighborhood, especially senior citizens who may not know about these programs. Contact the Community Development Department, City of Ypsilanti, telephone 483-1100.

ROOFING

Are you thinking of doing something about that leaky roof of yours . . . like repairing it? If so - consider this.

The average roof of 3 tab - 235lb - asphalt shingles properly applied to a moderate slope will last 15 years. A very steep roof will last perhaps 20 years.

If you have what you consider premature failure look for damage caused by wind, hail, falling tree limbs or other sources of impact damage. A valley may have suffered from ice damage or even may have been stepped on. Improperly installed flashing will not last the life of the roof.

So if you discover that you can in fact repair your roof instead of replacing it, you may save a considerable amount of money. However, be sure that what you are repairing is premature failure and not a roof that is beyond repair and in need of replacing.

NATIONAL HISTORIC PRESERVATION WEEK

May 6-12 is designated National Historic Preservation Week by the National Trust. The Heritage Foundation celebrates the week by making its annual presentation of Historic Structure Marker Awards. Coming as it does in the spring, Preservation Week provides us with an excellent opportunity to pause and review the progress that Ypsilanti has made towards preserving its architectural heritage. Historic Structure Marker awards are presented to property owners whose buildings are well maintained, either in a manner that closely approximates the original architectural condition, or appropriately renovated in a manner that does not detract from the original architectural style. The Foundation hopes that a continuing program to honor owners of historic structures will focus public attention on the unique architectural heritage of our community and encourage other owners to preserve and upgrade their buildings.

HISTORIC HOUSE TOUR

Buoyed up by the success of last year's home tour, the Foundation is planning another tour, but this time it will be held in conjunction with the "Ypsilanti Yesteryear" Festival. The tour which will run both Saturday and Sunday, August 25 and 26, will include different buildings each day. Among the buildings that will be featured on the tour are several on Huron Street, the old city hall, the old courthouse (soon to be the law offices of Stripp, Roberts, Manchester and Allen) and Sesquicentennial Hall; two on the south side, Child and Family Services Building and the home of John Littlejohn; downtown, the apartment of Ann Wallace; and on the east side, Casa Loma. Sunday's tour will feature Ypsilanti's historic churches.

As with last year's tour, guides will provide visitors with a brief orientation to the architectural style and historical significance of each structure. An illustrated brochure with a brief history of each structure will also be provided. Because the tour has been expanded to two days, a much larger number of guides will be needed this year.
